

# Earning A Scholarship To Attend CCU Summer Visual Arts Academy

## **Amount of the Scholarship**

Scholarships are for 100% of tuition. Parents/students pay nothing for tuition.

## **Scholarship Requirements**

1. Recommendation by a HCS Visual Arts Teacher
  2. Attend one or more Artistic GT Workshops at Edwards Building-CCU as follows:
    - a. Saturday, February 13 from 8:00 AM to 12:00 Noon
    - b. Saturday, February 13 from 1:00 to 5:00 PM
    - c. Saturday, February 20 from 8:00 AM to 12:00 Noon
  3. Screening and Interview for the Academy Scholarship on March 6, 2010
- Each of the 4-hour workshops is essentially the same and students may attend as many as they wish to feel comfortable with the screening requirements for March 6. We do not recommend that students attend back-to-back sessions on the same day. Students who qualified for the program last year may well be comfortable after one session. Students who have never qualified for a Summer Arts Scholarship before are encouraged to attend two sessions. There are no “do-overs” on the screening process. After March 6 scholarships will not be available.

## **Workshop and Audition Location**

The workshops and auditions will take place at a site to be announced. For each session students should report to register for the session 20 minutes before the session is scheduled to begin.

## **Forms and paperwork**

You do not have to complete paperwork in advance. All paperwork will be at the registration desk at the workshops. The fact that an art teacher has given you this information is all the “nomination” you need to attend a workshop.

## **Academy Housing**

Residential only. No day camp. Dorms supervised by staff and teachers.

## **Transportation to and from CCU**

Students/parents responsibility

Attached please find information about an outstanding opportunity for your child(ren).

1. Anyone can attend the CCU Summer Academies by paying full tuition but 6<sup>th</sup> through 11<sup>th</sup> graders enrolled in the Horry County Schools who qualify by being identified as artistically gifted and talented receive full scholarships to attend at no cost to parents.
2. Fine Arts teachers at your child's school can provide additional or clarifying information about this for you or your child. Feel free to talk to them.
3. You can call my office at 488-6742 for information.
4. Screening and audition are terms for the "test" to determine if a child is artistically gifted and talented.
5. The test is very challenging but the workshops are designed to give students the extra learning they need to be successful.
6. This program is funded and controlled by the State Department of Education and we have to meet a number of regulations regarding the amount of time students receive instruction. The workshops are part of that time requirement. No matter how gifted they are, students cannot receive a scholarship unless they attend at least one workshop.
7. Since there is no advance deposit required and since students must attend at least one workshop we will distribute applications for scholarships at that time. No need to fill anything out now. They just have to be at the university at the time and place described on the reverse page.
8. The CCU Summer Arts Academy is strictly residential. There is no day-camp option. Students live in the college dorms supervised by staff and teachers.
9. You have to get them to and from the college for Academy check-in and check-out.

**The most important thing for your child to earn a scholarship is to attend a Workshop in February.** There will be staff members from the school district and university there to supervise students but parents are welcome to attend the sessions with their children. We strongly recommend that students attend more than one session if they have never qualified for a Summer Arts Academy scholarship in the past.
