Additional Considerations Regarding AP/IB and Rigorous Coursework at the High School Level

- **College Entrance Exams**
 - **PSAT**
 - **ACT**
 - **SAT**
- **College Admissions**
 - **Ratio of AP courses offered and courses taken**
 - **Possible college credit earned with certain scores on the AP and IB exams**
 - **Rigorous coursework, including the senior year**
 - **GPA**

South Carolina Uniform Grading Policy

Applies to middle school courses carrying high school credit

- **Grades earned in middle school impact class rank and high school GPA.**
- **End-of-Course (EOC) Examinations in Algebra I and English I count for 20% of the overall grade in the course.**
- **Attendance: More than 10 absences result in failure of the course (factored into the GPA as a 50).**

South Carolina Uniform Grading Policy~Retaking a Course

- “A student who has taken a course for a unit of high school credit prior to his or her ninth grade year may retake that course regardless of the grade he or she has earned.”
- “A student who retakes a high school credit course from middle school must complete it before the beginning of the second year of high school. A student in grades nine through twelve, must retake a course by the end of the next school year or before the next sequential course (whichever comes first).”
- “In such a case, only the highest grade will be used in figuring the student’s GPA, however, both courses will remain on the high school transcript. The student may not retake the course if the course being replaced has been used as a prerequisite for enrollment in a subsequent course; i.e., a student may not retake Algebra 1 after having earned credit for a higher level mathematics course (Geometry, Algebra 2).”

When considering whether or not to retake a course, ensure the student has mastered the content in the current course so that he/she will be better prepared for the next course in the sequence.
